Urban regeneration and the economic crisis: past development and future challenges in Dublin, Ireland

The latest article of the section *Peripheries* focuses on Dublin as one of the most emblematic case among the medium to larger-sized European cities for the social and physical impact of urban economic restructuring and the role that this process has played at national level.

The article analyses the general trends in urban development in Dublin, focusing in particular on the case study of the docklands area which provides empirical evidence of the city's development trajectory, and discusses the key challenges that face future urban development in the city.



Towards Solar Urban Planning in Europe: The project "POLIS"

POLIS, an acronym for Identification and Mobilization of Solar Potentials via Local strategies, is a project co-financed by the Intelligent Energy Program - Europe, through which six European cities have committed to develop strategies for urban planning taken into consideration solar criteria (as well as promoting local policies that allow to use the existing solar potential). At the base of the project is the belief that only a local strategic approach will significantly increase the integration of decentralized renewable technologies and the small

scale technologies in the cities.

The project has seen the participation of municipalities of five European countries - the cities of Munich, Vitoria-Gasteiz, Paris, Lyon, Lisboa and Malmö - as well as partner technical experts from various disciplines.



Planning the historic centres in Italy: for a critical outline by G.B. Bonfantini

In its first part this article proposes a periodisation of the planning approaches to the 'inherited' parts of the city. Three stages of development of the urban plan for the existing city are outlined: reforming the old city, preserving the historic centre, revamping the existing city.

The second part of the article deepens some salient aspects of this last stage, regarding the modalities and the purpose of the plan for the historic centre and the historic city in the contemporary city. If in the past the recognisability and individuality of the historic centre have marked its alterity within an 'insular' urban plan, nowadays the historic centre has become a component of a more complex formation which has emerged in the recent debate with the name of 'historic city'.






Urban Design Ecologies: AD Reader edited by Brian McGrath

Cities are the symbiosis of diverse districts and the smaller units serve to provide important identity functions: business centers and amusement districts such as the City and the West End in London, technology and science quarters (Adlershof in Berlin), designer districts such as the Zona Tortona in Milan and the Fashion District in New York.





Hands on Urbanism 1850-2012. The Right to Green edited by Elke Krasny

This book is dedicated to the history of the idea of appropriating land in urban space. Since the shockwave of modernisation that accompanied industrialisation, towns and cities worldwide have had to face some very significant challenges: city-dwellers have always found a number of solutions in crisis situations and they are involved in bottom-up urban development. Self-build and self-organisation, settlements and fruit and vegetable gardening lead to other forms of collective cohesion, neighbourliness and fair distribution. Another world can be planted, as today's community gardeners are clearly showing.

Following many years of international research, the curator Elke Krasny presents 19 historical and contemporary case studies of bottom-up urban development in Chicago, Leipzig, Vienna, Bremen, New York, Paris, Hong Kong, Istanbul, Porto Alegre, Havana and Quito.








